

ORDINANCE NO. 782

AN ORDINANCE AMENDING CHAPTER 6.5, ARTICLE II, SECTION 6.5-17 OF THE DEFUNIAK SPRINGS, FLORIDA MUNICIPAL CODE ENTITLED "WAIVER OF FEES" AND CHAPTER 6.5, ARTICLE II, SECTION 6.5-20 OF THE DEFUNIAK SPRINGS, FLORIDA MUNICIPAL CODE ENTITLED "SPECIAL AGREEMENTS AND REQUESTS" AND CHAPTER 6.5, ARTICLE III, SECTION 6.5-32 OF THE DEFUNIAK SPRINGS, FLORIDA MUNICIPAL CODE ENTITLED "WAIVER OF FEES" AND CHAPTER 6.5, ARTICLE III, SECTION 6.5-35, OF THE DEFUNIAK SPRINGS, FLORIDA MUNICIPAL CODE, ENTITLED "SPECIAL AGREEMENTS" PURSUANT TO ORDINANCES 481 AND 545 AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the City Council of the City of DeFuniak Springs, Florida, that Chapter 6.5, Article II, Section 6.5-17 of the DeFuniak Springs, Florida Municipal Code Entitled "Waiver of Fees" and Chapter 6.5, Article II, Section 6.5-20 of the DeFuniak Springs, Florida Municipal Code Entitled "Special Agreements and Requests" and Chapter 6.5, Article III, Section 6.5-32 of the DeFuniak Springs, Florida Municipal Code Entitled "Waiver of Fees" and Chapter 6.5, Article III, Section 6.5-35, of the DeFuniak Springs, Florida Municipal Code, Entitled "Special Agreements" Pursuant to Ordinances 481 and 545, are hereby repealed in their entirety and amended to read as follows:

Chapter 6.5, Article II, Section 6.5-17 Entitled "Waiver of Fees" is hereby amended in its entirety to read as follows:

- A. Use of any of the Civic Center facilities may be without rent when sponsored by a nonprofit civic or community organization in cooperation with or as a part of a city program.
- B. Fees for use of the Civic Center facilities may be waived by the City Manager when the facilities are used by the Mayor, Council Member or staff member as a representative of the City.

and

Chapter 6.5, Article II, Section 6.5-20. Entitled "Special Agreements and Requests" is hereby amended in its entirety to read as follows:

Nothing herein shall prevent the City from entering into agreements with other governmental entities and agencies regarding use and fees.

and

Chapter 6.5, Article III, Section 6.5-32. Entitled "Waiver of Fees" is hereby amended in its entirety to read as follows:

- A. Use of any of the Chautauqua Auditorium facilities may be without rent when sponsored by a non-profit civic or community organization in cooperation with and as part of a City program.

B. Fees for use of Chautauqua Auditorium facilities may be waived by the City Manager when the facilities are used by the Mayor, Council Member or staff member as a representative of the City.

and

Chapter 6.5, Article III, Section 6.5-35. Entitled "Special Agreements" is hereby amended in its entirety to read as follows:

Nothing herein shall prevent the City from entering into agreements with other governmental entities and agencies regarding use and fees.

This Ordinance shall become effective upon adoption.
