**WHEREAS**, the Florida Legislature intends that local planning be a continuous and ongoing process; and

**WHEREAS**, the City Council of the City of DeFuniak Springs has adopted the DeFuniak Springs Comprehensive Plan, Ordinance No. 669 in November 2000; and

**WHEREAS**, Section 163.3191, Florida Statutes, directs local governments to periodically assess the success or failure of the adopted plan to adequately address changing conditions and state policies and rules; and

**WHEREAS**, Section 163.3191, Florida Statutes, directs local governments to adopt needed amendments to ensure that the plan provides appropriate policy guidance for growth and development; and

**WHEREAS**, the City Council of the City of DeFuniak Springs, acting as the designated Local Planning Agency, has reviewed the Evaluation and Appraisal Report, held the advertised public hearings, provided for participation by the public in the process; and

**WHEREAS**, the City Council of the City of DeFuniak Springs reviewed the Evaluation and Appraisal Report, held the advertised public hearings, and provided for comments and public participation in the process in accordance with the requirements of state law and the procedures adopted for public participation in the planning process;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DEFUNIAK SPRINGS, FLORIDA THAT:**

**Section 1:** The City Council of the City of DeFuniak Springs does hereby adopt the Evaluation and Appraisal Report for the DeFuniak Springs Comprehensive Plan, attached here as Exhibit A.

**Section 2:** The City Council of the City of DeFuniak Springs does hereby state its intention to amend the DeFuniak Springs Comprehensive Plan, Ordinance No. 669 in accordance with the recommendations contained in the Evaluation and Appraisal Report.

**Section 3:** The City Council of the City of DeFuniak Springs does hereby approve transmittal of the Evaluation and Appraisal Report to the Department of Community Affairs for the purpose of a sufficiency review in accordance with Section 163.3191, Florida Statutes.

**Section 4:** This Ordinance shall become effective immediately upon its passage.

**Section 5:** All Ordinances and parts of Ordinances in conflict herewith are repealed.

**Section 6: Effective Date.** This Ordinance shall be come effective as provided by law.
