

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DEFUNIAK SPRINGS, FLORIDA ADOPTING THE EVALUATION AND APPRAISAL REPORT FOR THE DEFUNIAK SPRINGS COMPREHENSIVE PLAN; STATING THE INTENT OF THE CITY COUNCIL OF THE CITY OF DEFUNIAK SPRINGS TO AMEND THE COMPREHENSIVE PLAN BASED UPON RECOMMENDATIONS CONTAINED IN THE REPORT; AND APPROVING TRANSMITTAL OF THE REPORT TO THE DEPARTMENT OF COMMUNITY AFFAIRS IN ACCORDANCE WITH SECTION 163.3191, FLORIDA STATUTES.

WHEREAS, the Florida Legislature intends that local planning be a continuous and ongoing process; and

WHEREAS, the City Council of the City of DeFuniak Springs has adopted the DeFuniak Springs Comprehensive Plan, Ordinance No. 674 in February 2001; and

WHEREAS, Section 163.3191, Florida Statutes, directs local governments to periodically assess the success or failure of the adopted plan to adequately address changing conditions and state policies and rules; and

WHEREAS, Section 163.3191, Florida Statutes, directs local governments to adopt needed amendments to ensure that the plan provides appropriate policy guidance for growth and development; and

WHEREAS, the City Council of the City of DeFuniak Springs, acting as the designated Local Planning Agency, has reviewed the Evaluation and Appraisal Report, provided for participation by the public and provided for comments in the process in accordance with the requirements of state law;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DEFUNIAK SPRINGS, FLORIDA:

**Section 1:** The City Council of the City of DeFuniak Springs does hereby adopt the Evaluation and Appraisal Report for the DeFuniak Springs Comprehensive Plan, attached here as Exhibit A.


**Section 2:** The City Council of the City of DeFuniak Springs does hereby state its intention to consider amendments to the DeFuniak Springs Comprehensive Plan based on recommendations contained in the Evaluation and Appraisal Report.

**Section 3:** The City Council of the City of DeFuniak Springs does hereby approve transmittal of the Evaluation and Appraisal Report to the Department of Community Affairs for the purpose of a sufficiency review in accordance with Section 163.3191, Florida Statutes.

**Section 4:** This Resolution shall become effective immediately upon its passage.

**Section 5:** All Resolutions and parts of Resolutions in conflict herewith are repealed.
