

DeFuniak Springs City Council  
Canvassing Board  
April 11, 2019

The following canvassing board members were present: Councilmember Henry Ennis, City Electorate Jack Owen and Debra Gibson, City Manager Mell Smigielski, City Attorney Clay Adkinson and City Clerk Loretta Laird. Walton County Supervisor of Elections representatives included: Bobby Beasley, Ryan R Messer, Brandon Rose, and Dana Spence.

Councilman Ennis called the meeting to order at 10 a.m. at the Walton County Board of County Commissioners board room. Walton County Supervisor of Elections Officer Bobby Beasley discussed the machine recount process then proceed with Canvassing board members Owen, Ennis and Gibson to obtain the DS450 machine that would provide for the machine recount in accordance with Florida Statute 102.141(7). Canvassing board members confirmed the seal numbers on the DS450 machine with Supervisor of Elections staff performing a logic and accuracy testing on the machine.

The canvassing board members confirmed the previously determined results along with City Marshal candidates James W Hurley, Jr. and Mark Weeks. The canvassing board members verified the seals on each ballot type container starting with absentee/mail ballots. The absentee results are as follows: Donald L. Graham: 37 votes; James W. Hurley, Jr.: 315 votes; and Mark A. Weeks: 163 votes and one under vote for a total of 516 absentee/mail ballots.

The canvassing board members verified the seals on the election day ballots. The election day results are as follows: Donald L. Graham: 153 votes; James W. Hurley, Jr.: 273 votes; and Mark A. Weeks: 420 votes and two under votes for a total of 848 election day ballots.

All under votes were presented to the canvassing board and two city marshal candidates and placed in a manila envelope by Supervisor of Elections representative Brandon Rose. City Clerk Laird announced the absentee/mail and polling results and then provided the second unofficial result totals for the city marshal race as follows:




The canvassing board members verified seals on the 2019 election ballot containers and the DS450 machine.
