The following members were present: Mayor Bob Campbell; Mayor Pro-Tem Robert McKnight (Seat 2); Councilmember Todd Bierbaum (Seat 1); Councilmember Kevin Crystal (Seat 3); Henry D. Ennis (Seat 4); and Councilmember Wayne Graham (Seat 5). Also present were Clay Adkinson, City Attorney; Mell Smigielski, City Manager; Deputy City Manager Carisse LeJeune; Debra Gibson, Finance Director; and Maryanne Schrader, City Clerk.

Mayor Campbell called the meeting to order at 5:02 p.m.

Final Millage Rate

City Attorney Clay Adkinson stated this was the final Public Hearing on the 2020/2021 Fiscal year budget and tentative millage.

City Attorney Clay Adkinson said the Council will be voting on the millage rate at 5.0000 mills which is greater than the rolled-back rate of 4.7702 mills by 4.82%.

Motion by Councilmember T. Bierbaum and seconded by Councilmember K. Crystal to adopt a millage rate for the 2021 fiscal budget year at 5.0000 mills.

Attorney Clay Adkinson asked for public comment. Hearing none, Council voted.

Final 2020/2021 Fiscal Budget

City Attorney Clay Adkinson said the Council will be voting to adopt the final operating budget of \$32,495,448 for the FY 2020/2021 budget year.

Motion by Councilmember K. Crystal and seconded by Councilmember T. Bierbaum to adopt the final operating budget of \$32,495,448 for FY 2020/2021 budget year.


Attorney Clay Adkinson asked for public comment. Hearing none, Council voted.
