Budget Final Public Hearing Minutes

The following Council members were present: Mayor Bob Campbell; Councilmember Robert McKnight (Seat 2); Councilmember Kevin Crystal (Seat 3); Councilmember Henry D. Ennis (Seat 4), and Councilmember Anthony Vallée (Seat 5). Staff present: City Manager Robert Thompson, City Attorney Clayton Adkinson, Finance Director Debra Gibson, and City Clerk Maryanne Schrader. Mayor Pro-Tempore Todd Bierbaum (Seat 1) was excused.

Mayor Bob Campbell called the meeting for the budget hearing to order at 5:01 p.m.

2. Final FY22 Millage Rate Adoption

City Attorney Clayton Adkinson opened the Public Hearing stating the purpose of the meeting is to hold the final Public Hearing on the millage rate and budget. He noted no one from the public were present.

City Attorney Clayton Adkinson said the millage rate of 5.5000 is greater than the rollback rate of 5.2525 mills by 4.71%. City Attorney Clayton Adkinson read Resolution 2021-18, a Resolution adopting the final levying of Ad Valorem taxes for Walton County for Fiscal Year 2021-2022 and providing for an effective date.

Motion by Councilmember K. Crystal and seconded by Councilmember A. Vallée to adopt the final millage rate for the fiscal budget year at 5.5000 mills and adopt the resolution.

3. Final FY22 Budget Adoption



City Attorney Clayton Adkinson read Resolution 2021-19, a Resolution of the City of DeFuniak Springs of DeFuniak Springs of Walton County, Florida, adopting the Final Budget for Fiscal Year 2021/2022; providing for an effective date.

Motion by Councilmember K. Crystal and seconded by Councilmember A. Vallée to adopt the final budget of \$42,799,743.00 and adopt the resolution.
