- ▶ Qualifying and absentee Voting will be held at the Supervisor of Elections Office, Walton County: 571 US Highway 90 East, DeFuniak Springs, FL 32433. Please contact the Supervisor of Elections Office at 892-8112 for more information.
- ▶ No one may qualify for a position before the qualifying period. However, this does not prevent anyone from announcing they intend to seek public office, opening an account, and receiving and expending funds after they pre-file. Reports begin with pre-filing documents.
